PDBA COMMUNITY MEETING MINUTES APRIL 2015

Board of Directors: Phil Wojtowicz, Kathie Henk, Kyle Westberg, Robert Karazim, Ted Buckner, (Bob Waun absent out of state on business)

Phil Wojtowicz Begins the meeting by announcing the changes of the Board of Directors. Glen Konopaskie is stepping down as president to assume the role of Downtown Director. Phil will be assuming the role of Board president. This change will not affect PDBA daily business as no communication channels will change.

Phil then introduces Pontiac Mayor Deirdre Waterman so that she can give her monthly update.

Mayor Waterman Summary: She starts off with introducing Pastor Doug Jones, leader of the Greater Pontiac Community Coalition and head of Pontiac's Woodward Dram Cruise (WDC) event for the last fifteen years. Mayor Waterman wants to see Pontiac's WDC event move successfully into its next phase. She wants The City of Pontiac (CoP) to have a voice in WDC planning with the intent of highlighting all of the great things Pontiac has to offer. She wants to make sure Pontiac is shown in a positive light and that all WDC requirements are met. It is Mayor Waterman's feeling that the PDBA is wel qualified to head the WDC and make it an attraction for new business. She then gives the floor to Pastor Jones.

Pastor Jones Summary: Pastor Jones begins by describing the beginnings of the PDBA. Pastor Jones has partnered with Kathie Henk for over 20 years on various projects. The first being a rummage sale. That sale saw a uniting of volunteers that would come to from what is now known as the PDBA. He is turning he running of WDC over to the PDBA ecause he is confident PDBA is more than capable to manage the event. He sees WDC as a driver to show off Pontiac culture, safety, and business.

 - RK moves to vote on hiring Major Group
- Christian provides context on how PDBA came to hire a promotor.
 - After much research in prior years, promotions found that it did not have the compacity to pull off WDC

- It was then decided that the best move would be to hire a promotor to head the WDC on behalf of the PDBA
- Blair asks about the financial risk and contribution on part of the PDBA
 - Glen stated Major assumes all risk
- Pastor Jones: PDBA is a part of Pontiac and the vote is to take the event over for Pontiac
- Major is a gret partner because of Pontiac roots
- Question regarding parking at WDC
 - PDBA will remain in control of parking
- Joe H gives WDC history
 - o All that will change is PDBA is in charge
 - In favor of 2 votes
 - o Birmingham is a good example of contractor relationship
- Robert makes the two motions seconded by Jim Trebus
- Christian adds more findings od the WDC committee from prior years
 - Lots of ideas, little funds
 - We need sponsorships. It doesn't make financial sense to not accept them
 - o Early sponsors have been identified
 - Need yes vote to move forward
 - Suggests motion to vote on income package
- Vote called: PDBA to assume control of the Woodward Dream Cruise event for the City of Pontiac.
